The categories of information that we collect, process, hold and share about members of the Governing Board include:

- Personal information (such as name, address, contact details, term of office and business interests)
- Disclosure and Barring Service information

Why we Collect and Use this Information

We use this data to:

- Inform the appointment of governors;
- Communication of Governing Board matters:

The Lawful Basis on which we process this information

We will not give information about you to anyone without your consent, unless the law and our policies allow us to. We collect and use personal data in order to meet legal requirements and legitimate interests set out in the UK General Data Protection Regulations (UK GDPR), including those in relation to the following:

- Article 6 and Article 9 of the UK GDPR
- Education Act 1996

Collecting this information

Whilst the majority of data you provide to us is mandatory, some of it is provided to us on a voluntary basis. In order to comply with the data protection legislation, we will inform you whether you are required to provide certain school information to us or if you have a choice in this.

Storing this information

Personal data relating to the Governing Board at Downsview Primary & Nursery School is stored in line with the school's Data Protection Policy. In accordance with the UK GDPR, the school does not store personal data indefinitely; data is only stored for as long as is necessary to complete the task for which it was originally collected, and in line with the school's Data Retention Policy.

Why we share information

We will not give information about you to anyone outside the school or Local Authority (LA) without your consent, unless the law and our policies allow us to.

We are required to share information about our Governing Board with the Croydon local authority (LA) and the Department for Education (DfE). This data sharing is used to inform them of the membership of Governing Board and its responsibilities.

Requesting access to your personal data

What are your rights?

You have the right to:

- object to processing of personal data that is likely to cause, or is causing, damage or distress;
- prevent processing for the purpose of direct marketing;
- object to decisions being taken by automated means;
- in certain circumstances, have inaccurate personal data rectified, blocked, erased or destroyed;
- claim compensation for damages caused by a breach of the Data Protection regulations.
